- By Taxi to “Eingang Ludwig-Erhard-Anlage“ (LEA Entrance), which is directly next to the Maritim Hotel

By Train

- The easiest way is to take the suburban trains S3 (Bad Soden), S4 (Kronberg), S5 (Bad Homburg/Friedrichs-dorf) and S6 (Friedberg/Groß Karben) to the “Messe” stop, or the U4 to the “Festhalle/ Messe” stop. You can change from the U1, U2, U3, U6 and U7 underground lines to Messe-bound suburban trains at Haupt-wache, and from lines U5, U6 and U7 at Konstablerwache (see map page 30–32 of [Information & Tips of your Arrival](#)).

By Car

- If you arrive by car, all you have to do is follow the signs for “Messe”, exiting at the Westkreuz Frankfurt junction. The overhead signs will lead you directly to the exhibition complex (see map page 24–25 of Information & Tips of your Arrival).
- If you use a GPS Navigation System please use the following destinations:
 - Via Gate North: Katharinenkreisel, please follow the signage to “Tor Nord”
 - Via Gate West: Straße der Nationen leads directly to “Tor West”
(Older GPS’: Am Römerhof)

Venue technical information



Please keep in mind strict venue regulations related to stand construction and structural approval fee, applied directly by the venue. More information in **Structural calculations for stands** paragraph in the [EWEA OFFSHORE 2013 rules and regulations for space only stands](#) document.

Deliveries can arrive on all sides of the hall, and set-up and dismantling are made easy by the eight heavy goods

lifts with a load capacity of 15 tons.

Visitors are brought to their desired destinations by a number of escalators and passenger lifts. The mezzanine of Hall 3 is connected to the Via Mobile moving walkway, which brings visitors to 'Forum', where the conference will be held.

Hall 3.0

All mains for power, spotlights, network and telephone cabling, as well as plumbing will be run into your stand via service ducts in the asphalt hall floor. **Maximum load-bearing capacity 25KN/m².**

There are 0.85 x 0.85 m concrete pillars in this hall. Please refer to the technical plan of the hall to see if the pillars are next to your stand.

Hall 3.1

All mains for power, spotlights, network and telephone cabling, as well as plumbing will be run into your stand via service ducts in the asphalt hall floor. **Maximum load-bearing capacity 15KN/m².**

There are no concrete pillars in this hall.

Parking

Exhibitor parking for build-up and breakdown is free. Parking permits for the event days can be ordered using the booking form below.

Parking permits can only be issued as far as parking spaces are available and these permits will only be valid for the duration of the event.

Please note the deadline given for placing the order is **8 October 2013**. Permits will be sent no later than two weeks before the event begins.

However, spaces permitting, it is possible to pay onsite at €14 per day if you have not been able to pre-order, depending on the availability.

Cars of up to 2.5 metric tons maximum gross weight may be parked in/on Messe Frankfurt's parking facilities. For further information, please contact the parking company.

Access

All exhibitors and contractors must wear a contractor wristband at all times during the build-up and breakdown of the exhibition. Contractor wristbands should be collected from the security personnel upon arrival on site. They may also be collected from the EWEA Exhibition Operations Team office.

During the exhibition open hours, all participants are requested to wear a badge. For more information, please refer to the registration section in the manual.

All vehicles delivering exhibits or stand-fittings must present a vehicle delivery pass. For security reasons, a completed vehicle delivery pass must be displayed in the vehicle's windscreen at all times. Transport and deliveries will be directed to vehicle access doors closest to your stand. Security guards or traffic personnel can help direct you to the correct door.

In order to provide a smooth flow of traffic during set-up and dismantling periods and during the event, the traffic regulations below must be observed at all times.

The exhibition grounds are the private property of Messe Frankfurt. The provisions of German road traffic regulations apply throughout the exhibition grounds and on/in Messe Frankfurt's parking facilities.



The speed limit on the exhibition grounds is 30 km/h.

Within exhibition halls and elsewhere traffic conditions demand, drivers shall drive at walking speed. Drivers shall come to a full stop at the entrances to, and exits from exhibition halls and shall verify that gate heights are adequate.

- No vehicles are permitted in the exhibition halls
- Vehicles' engines shall be shut off during loading/unloading.
- Caravans/ campers may not be used on the exhibition grounds.
- Illegally parked vehicles, trailers, containers, and goods of any kind may be removed by authorised towing companies working under contract to Messe Frankfurt at their owners' or operators' expense and risk.
- The instructions of personnel assigned by Messe Frankfurt to direct and supervise traffic and the associated information shall be followed at all times.

Driving any type of vehicle on the exhibition grounds requires a permit from Messe Frankfurt, is at drivers' own risk, and is prohibited at all times during events.
